





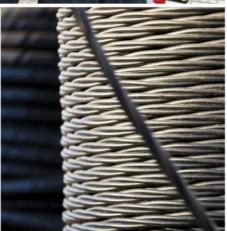

Edenor announces second quarter 2015 results

Buenos Aires, Argentina, August 11, 2015. Empresa Distribuidora y Comercializadora Norte S.A. (NYSE: EDN; Buenos Aires Stock Exchange: EDN) ("EDENOR" or "the Company"), Argentina's largest electricity distributor, today announced its results for the second quarter of 2015. All figures are stated in Argentine Pesos and have been prepared in accordance with International Financing Reporting Standards ("IFRS"). Solely for the convenience of the reader, Peso amounts as of and for the quarter ended on June 30, 2015 have been translated into U.S. Dollars at the selling price quoted by Banco de la Nación Argentina of AR\$ 9.09 per U.S. Dollar.

HIGHLIGHTS

Salaries increase

On June 8th, 2015 an agreement was entered between the Ministry of Labor, Employment and Social Security, Edesur S.A, the Electric Light and Power Labor Union, the Association of Supervisory Personnel of Energy Companies and the Company, pursuant to which the following was established:

- A salary increase of 16%, since May 1st, 2015 and of a non-cumulative 11.8% since September 1st, 2015, for a year period term.
- And an additional 11.9% increase for the period May 2016 to October 2016, to be calculated over the salaries of April 2016.

The mentioned Resolution applies also to contractors whose employees are framed in the collective bargaining agreement of the above-mentioned union associations.

Resolution 32/15. Note N°. 1208

As established by the Energy Secretariat through Note No. 1208 dated June 29, 2015, the amounts owed to CAMMESA have been recalculated based on new criteria. On July 22, 2015 the owed amounts were agreed, and CAMMESA issued the LVFVD (Sale Settlements with Maturity Dates to be Determined) in compensation. The net result of this agreement was a profit of AR\$ 254.4 million, mainly due to the recalculation of interests taking into account the currently determined debt, which had been added in the "Financial Expenses" line item in the Statement of Comprehensive Income (loss) of the Financial Statements.

Resignation of Mr. Edgardo Volosín as CEO of the company

On June 29, Mr. Edgardo Volosín tendered his resignation as Chief Executive Officer of the company, for strictly personal reasons. This resignation was effective since July 1, 2015.

In consequence to this event, the Company's Chairman of the Board, Mr. Ricardo A. Torres, became also its CEO. Notwithstanding the considerations above, Mr. Volosín continues acting as regular member of the Company's Board of Directors.



Loans agreements with CAMMESA for Extraordinary Investment Plan

In September 2014, the Energy Secretariat instructed CAMMESA to enter into a Mutuum and Guarantee Assignment Agreement with the Company for an initial amount of AR\$ 500 million in order to provide the necessary financing to cover the Extraordinary Investment Plan as a consequence of the temporary insufficiency of the revenue deriving from Resolution 347/12. On December 2014, this agreement was extended, for an additional amount of AR\$ 159.4 million and subsequent to year-end, on January 2015, March 2015 and June 2015, new extensions were filed, totalizing an available amount of AR\$ 2,466.3 million.

As of June 30, 2015, these debt amounts to AR\$ 908.7 million, comprised of AR\$ 831.6 million principal and AR\$ 77.1 million in accrued interest.

Revenue from sales increased 5.5% to AR\$ 899.4 million in the second quarter of 2015 compared to AR\$ 852.7 million in the second quarter of 2014, mainly due to an increase in volume of energy sold in GWh for about 3.2%, a 1.2% growth in revenues related to the application of Resolution 347/12, and higher income from the right of use on poles.

Volume of energy sold increased 3.2% to 5,475 GWh in the second quarter of 2015 from 5,304 GWh in the second quarter of 2014, basically due to an increase of 10.4% in medium commercial customers and an 8.3% increase in industrial customers.

Electricity power purchases increased 1.7% to AR\$ 477.1 million in the second quarter of 2015 compared to AR\$ 469.2 million in the same period of 2014, mainly due to the increase in energy sales described above, partially offset by a decrease in energy losses and a reduction in mobile generation.

Net operating income increased AR\$ 141.5 million amounting a gain of AR\$ 215.1 million in the second quarter of 2015 compared to a gain of AR\$ 73.6 million in the same period of 2014. This positive result was due to the income increase obtained through Resolution 32/15 of AR\$ 1,054.8 million, composed by AR\$ 942.1 million additional income obtained from the difference between the "theoretical" tariff schedule and the current tariff schedule, AR\$130.1 million from the PUREE funds that are considered as part of Edenor's income, partially offset by a decrease in the amounts related to the Mutuum and Guarantee Assignment Agreement of AR\$17.4 million.

These increases were partially offset by higher transmission and distribution expenses of AR\$ 97.3 million, by higher administrative expenses of AR\$ 60.5 million and an increase in selling expenses of AR\$ 48.3 million. The main expenses increase are related to a raise in salaries, which represent approximately 95% of the total growth.

Net income shows an increase of AR\$ 239.1 million, amounting a gain of AR\$ 254.9 million in the second quarter of 2015, compared to a gain of AR\$ 15.8 million in the same period of 2014, mainly due to the income recognition of Resolution 32/15 described above, and to an increase of AR\$ 327.4 million in financial results principally due to the profit obtained with the recalculation of the debt with CAMMESA.



Adjusted EBITDA

Adjusted EBITDA has increased to a gain of AR\$ 313.0 million in the second quarter ended June 30, 2015, compared to a loss of AR\$ 479.3 million in the same period of 2014.

Capital Expenditures

Edenor's capital expenditures during the second quarter of 2015 totaled AR\$ 486.9 million, compared to AR\$ 368.8 million in the second quarter of 2014. This increase was mainly due to the increase in costs and key facilities for ensuring the proper provision of the service.

Our capital expenditures in the second quarter of 2015 mainly consisted of the following:

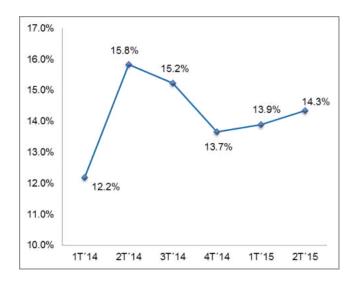
- AR\$ 26.8 million in new connections;
- AR\$ 310.1 million in grid enhancements;
- AR\$ 63.9 million in network maintenance and improvements;
- AR\$ 1.2 million in legal requirements;
- AR\$ 8.0 million in communications and telecontrol;
- AR\$ 77.0 million of other investment projects.

For the six-month period ended June 30, 2015, our Capital Expenditures totalized to \$AR 821.2 million compared to Ps. 643.8 million in 2014, including capitalized costs in property, plant and equipment.



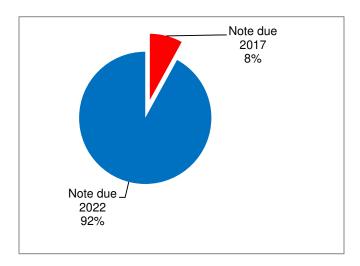
Energy Losses

In the second quarter of 2015 energy losses decreased to 14.3% compared to 15.8% in the same period of 2014.



Indebtedness

The outstanding principal amount of our dollar denominated financial debt is US\$ 191.2 million, consisting of US\$ 14.8 million principal amount of Senior Notes due on 2017 and US\$ 176.4 million principal amount of Senior Notes due on 2022.

Empresa Distribuidora y Comercializadora Norte S.A. (Edenor) is the largest electricity distribution company in Argentina in terms of number of customers and electricity sold (both in GWh and Pesos). Through a concession, Edenor distributes electricity exclusively to the northwestern zone of the greater Buenos Aires metropolitan area and the northern part of the city of Buenos Aires, which has a population of approximately 7 million people and an area of 4,637 sq. km. In 2014, Edenor sold 21,292 GWh of energy and purchased 24,860 GWh of energy, with net sales of approximately AR\$ 3.6 billion and net loss of AR\$ 779.7 million.
